#### **Office Memorandum**

Subject: Scholarship to eligible students of Jammu and Kashmir under the J&k Special Scholarship Scheme

This is to notify that the All India Council for Technical Education have launched "J&K Special Scholarship Scheme" on selection basis for students from Jammu & Kashmir Region for academic session 2014-2015. Students whose parental annual income is upto Rs. 6, 00,000/- would be eligible to apply. The income shown by the applicants would be subject to inquiry. The applicant should not be recipient of any other scholarship/financial assistances.

The maximum amount of scholarship would be **Rs. 1.25/-** lakhs per annum for Technical & Integrated courses towards meeting tuition fees as per actual or as per the norms laid down by State Fee Regulatory Authority, whichever is less and within the overall ceiling of the guidelines. In addition to this, hostel fees and incidentals will also be given for the course. The ceiling for this will be **Rs. 1.00/-** lakhs per annum, as per actual subject to production of receipts.

Students with domicile of **Jammu & Kashmir** who have passed Class XII or equivalent exam through the State Board of Jammu & Kashmir and from Central Board of Secondary Education (CBSE) affiliated schools situated within **Jammu & Kashmir** would be eligible. Students pursing 'Integrated Courses' are also eligible for the scholarship.

## **Instructions**

## <u>Procedure/Documentation for release and settlement of claims under the Special</u> Scholarship Scheme for Jammu & Kashmir

In order to bring clarity about the documents to be submitted along with the claim and also to put in place standardized reporting mechanism/formats so as to facilitate timely settlement of claims and release of funds under the Special Scholarship Scheme for Jammu & Kashmir, the following procedure and standard document formats have been evolved in consultation with Internal Finance Division of Ministry of HRD and AICTE:

#### A. Fresh Cases:

- (a) Utilization Certificate in the format prescribed as **Annexure-I** for utilization of **at least 90%** of the funds provided for the preceding Academic Year. The unspent balance may be initially adjusted in the fresh release, which may be finally settled on receipt of the UC for utilization of the balance funds of the previous academic year within 6 months. Besides, as suggested by AICTE, Receipt and Payment Account maintained for the Scholarship by the institute for the funds released in the previous financial year, if any, in the format prescribed as **Annexure-II**
- **(b)** List of students along with head-wise break-up of charges claimed under the scholarship Scheme. **Annexure-III**
- (c) Fee receipts tuition as well as Hostel charges, in original, where charged.

  Annexure-IV. In cases where fee is not charged by the College, a certificate from the college that no fee towards tuition as well as Hostel charges has been charged from the student(s) in the format prescribed as Annexure-IV(a)
- (d) Certificate from the college authority about the fee structure—Tuition and Hostel charges, duly supported by the Resolution of the Governing Board/State Fee Regulatory Authority's order with regard to the Fee structure (Annexure –V).
- (e) In cases of the institute which does not come under the purview of the State Fee Regulatory Authority, a certificate in the format prescribed as Annexure -V (a)
- (f) In cases where the college/institute has not charged the fee from the students, the fee receipt need not be insisted upon and the scholarship may be released on the basis of the certification by the authorized signing authority of the college/institute. The claim should be restricted to the ceilings prescribed in the Scheme guidelines or the fee structure prescribed by the State Fee Regulatory Authority, if it exists, whichever is lower.

- (g) In respect of students who are not staying in the College Hostel at their own volition and claiming the rent of the accommodation hired by them, the rent may be given on the basis of Rent Agreement and a Certificate from the college authority about the reasonableness of the rent claimed as in Annexure-VI and restricted to the Hostel fee charged by the College/Institute or the ceiling of scheme guidelines, whichever is less.
- (h) Cash Memo (Annexure -VII) for purchase of Books, duly countersigned by the authorized signing authority of the college/institute and the claim may be restricted to Rs. 15,000/- within the overall ceiling of Rs. 1.00 lakh under the Hostel fee head.
- (i) Affidavit to be submitted by the Head of Institute about compliance with the terms and conditions of the Scheme (as suggested by AICTE) Annexure VIII

#### B. Renewal Cases:

- (a) Utilization Certificate in the format prescribed as Annexure-I for utilization of at least 90% of the funds provided for the preceding Academic Year. Besides, as suggested by AICTE, Receipt and Payment Account maintained for the Scholarship by the institute for the funds released in the previous financial year, if any, in the format prescribed as Annexure-II
- **(b)** List of students along with head-wise break-up of scholarship paid to the students. **(Annexure -IX)**
- (c) Fee receipts tuition as well as Hostel charges, in original, or copies, if already submitted. (Annexure -X)
- (d) Certificate from the Principal of the Institute that the student concerned has been promoted to the next class/level (Annexure-XI)
- (e) <u>Cases where fee has been charged from the students:</u> Signed receipt from each student for receipt of the scholarship, inter-alia, indicating the amount, through the College/Institute, duly countersigned by the prescribed authority of the college/institute. (Annexure -XII)
- (f) <u>Cases where fee has not been charged from the students:</u> Certificate from each student, certifying that he has been informed by the College authorities that a certain amount has been received by the College from the Government towards his scholarship under the Scheme and that the college has not charged any fee from him under the various heads for which the scholarship has been granted to the extent of the scholarship (Annexure -XIII)
- (g) Certificate from the college authority about the fee structure—Tuition and Hostel charges, duly supported by the Resolution of the Governing Board/State Fee Regulatory Authority's order with regard to the Fee structure (Annexure –V).

- (h) In cases of the institute which does not come under the purview of the State Fee Regulatory Authority, a certificate in the format prescribed as Annexure -V (a)
- (i) In respect of students who are not staying in the College Hostel at their own volition and claiming reimbursement of the rent of the accommodation hired by them, **Rent receipts** duly countersigned by the college authorities along with a Certificate from the college authority about the reasonableness of the rent claimed as in **Annexure VI** and the rent should be restricted to the Hostel fee charged by the College/Institute or as per the ceiling of the guidelines, whichever is less.
- (j) Cash Memo for purchase of Books, duly countersigned by the college authorities and the claim may be restricted to Rs. 15,000/- within the overall ceiling of Rs. 1.00 lakh under the Hostel fee head. (Annexure-VII)
- (k) Affidavit to be submitted by the Head of Institute about compliance with the terms and conditions of the Scheme (as suggested by AICTE) Annexure -VIII
