

Security deposit should remain valid for a period of sixty days beyond the warranty period. **No interest shall be paid on Performance Security.** The Performance Security will be forfeited by order of the Competent Authority in the event of any breach or negligence or non-observance of any terms & conditions of the contract or for unsatisfactory performance or for non- acceptance of the supply order. EMD will be released after receiving of transaction receipt of RTGS/NEFT of security amount.

10. **Supply, Installation and Testing of the above items must be completed within 2-3 weeks from the date of receipt of the order. If the supply, Installation and Testing delayed beyond the stipulated time of completion, penalty of 1% per week or maximum 10% of the total cost may be imposed at the discretion of the competent authority.**
11. All disputes are subject to the jurisdictions of Allahabad.
12. Price Basis & applicable Tax claim: Price should be quoted by interested Tenderer is inclusive of all up to F.O.R. IIITA, Allahabad basis. Vendor should clearly mention the Rate of applicable GST Tax separately, if firm will not mentioned the Taxes clearly on their Price Quotation, IIIT - Allahabad will assume that the quoted price is inclusive of all and no extra amount in later stage shall be paid by IIIT, Allahabad on account of Taxes.
13. If it is found that items are of sub-standard quality and not conforming to the required specifications, the firm will have to replace the fake/ sub-standard items with genuine ones immediately but they will also be liable to be blacklisted.
