**Tender Methodology:** The Tender Methodology proposal to be adopted will be in two stages comprising the Expression of Interests (EOI) in the first stage. The Second stage of tendering process will comprise of inviting techno-commercial bids. The evaluation procedure for the tendering process would follow the quality cum cost based system. Comprehensive warranty of RO plant will be 5-7 years. The cost associated with the preparation and submission of response of EOI and tender shall be-borne by the bidders.

#### **Technical Evaluation Criteria-**

- a) Bidder should have a minimum experience of three years in relevant field specially in installation of RO plants of 1000 LPH or more capacity. Firm should furnish two work order completion certificate for minimum 1000 LPH capacity or more (submit documentary evidence).
- b) Only OEM or their authorized channel partners should participate (submit documentary evidence).
- c) Bidder shall have to submit an undertaking on the company letter head that the firm/company's is not black listed from any organization.

#### Terms of Reference: Terms of reference for this EOI are as follows:-

- a) Only short listed agency will be issued tender documents with an invitation to submit the technical & financial bid in two separate envelopes sealed all together in a big envelope subscribing the name of the tender, reference number, date of closing & the concern authority.
