The envelope should also bear the name, address and seal (if available) of the tenderer. Bid Security : Bid Security (BS) fee amount **Rs.1,000/- (One thousand Only)** should be directly transfer into the bank account of Indian Institute of Information Technology, Allahabad through RTGS/NEFT and the tender document should be accompanied with the transaction receipt of RTGS/NEFT (Any bid without BS fee receipt will not be considered). **4. Inspection:**

The vehicle to be auctioned is available for inspection on "as is where is basis" with "only visual inspection is permissible" by the Tenderer at the "Parking Area, near Temple Premises, Jhalwa Campus, IIIT-Allahabad" between 3:00 pm to 5:00 pm on any working day during the week. Bidders/Tenderers should inspect the Vehicle at the site and get satisfied of the conditions and quality of the vehicle to be purchased before offering the tender rate. You may contact Sh. L. N. **5. Tender Opening:**

Tender will be received only up to the date and time prescribed in Para (1). All the Tenders received will be opened on **09/01/2020 at 4:00 PM** by the Competent Authority at the **Main Admin Block, Board Room** in the presence of the tenderers or their authorized representatives (not more than one), who choose to be present. Only participating tenderers or their representative will be permitted. Vendors are desired to submit their authorization letter along with a photocopy of their photo identity card at the time of participation in the opening of Tender.

**6. Acceptance:**

- i. The tenderer should quote the rate for purchase of the vehicle both in words and in figures. If there is any difference in the figures and that in the words, the rate quoted in words will only be taken into account.
- ii. Price quoted by the bidder should not be less than the reserved price fixed for the vehicle by the authority.
- iii. The highest bidder shall not be allowed to withdraw his bid, failing which his bid security amount will be forfeited. The next highest bidder will be awarded the contract if he will be agreed to pay the amount quoted by H1 bidder.

**7. Taxes:**

Applicable taxes admissible will be collected over and above the sale price in accordance with the Central Government Rules in force. As such the tenderer should quote the rate exclusive of Taxes while offering the rate in the tender.

**8. Payment:**

- i. Successful bidder will pay 100% of the total amount on the spot or within 24 hours through Bank Transfer/Card Payment/NEFT/RTGS/DD as per bank details given at s.no. 03 of terms and conditions, otherwise the bid will be cancelled and the amount will be confiscated. Successful Bidder will also have to pay GST @18% or as applicable, plus other Government taxes as admissible under existing rules. In case of renewal of registration, the Fitness Penalty etc. would be borne by the Institute while other Registration Transfer charges / formalities would be borne by the Successful bidder. In case of purchase for use in SCRAP, the Institute will get the cancellation of Registration Certificate done at its end with RTO.

- ii. The vehicle will be released for delivery to the successful tenderer only after the full payment of the entire bid amount including taxes.

**9. Delivery:**

- a) After complete payment and on receipt of delivery authorization from the Competent Authority, IIIT-Allahabad, the successful tenderer should remove the condemned vehicle from IIIT-Allahabad Campus at his own risk and his own cost within 24 hours from the time of receipt of delivery authorization, failing which a ground rent of 1% of the highest Bid Amount will be collected extra, for each day.
- b) The person authorized by bidder will be allowed to take the delivery. The Bidders are required to produce any of documentary evidence for "proof of their address" with contact details.
- c) The address given in the tender shall be "deemed to be Bidder's" address and correspondence sent on that address shall be considered to have been delivered to the bidder.

**10. Loss or Damage:**

Once the Tender is finalized and the entire Bid Amount collected and delivery authorization issued, Institute will not be responsible either for safe custody or for any loss or damage of the vehicle, beyond **10 days on finalization of tender & bid security will be forfeited.**

**11. Other Conditions:**

- 1) Bidders must provide attested copies of their PAN Card, ID and Address Proof (e.g. Copy of ADHAAR CARD, Voter ID Card, Passport, and Driving License) and two PASSPORT SIZE PHOTOS duly self-attested.
- 2) The H1 bidder is responsible for all acts done either by himself or by his authorized representatives.
- 3) In case of any dispute, it should be clearly understood that the decision of the Director, IIIT-Allahabad shall be final.
- 4) The Competent Authority reserves all rights to accept or reject any tender or all without assigning any reason thereof and the decision of the Competent Authority will be final and binding on all.
