Annexure-III

Technical Terms & Conditions:

By way of this Annual maintenance contract, it is expected that:

- 1. The firm is required to be an official Cisco services partner.
- 2. Manufacturer Authorization Form (MAF) is required to be submitted along with bid.
- 3. The firm will Provide complete support and maintenance for the devices listed above.
- 4. The firm will depute one onsite support network engineer at institute premises during AMCperiod who will be responsible for monitoring and maintaining health status of Network devices under AMC. The service engineer will maintain a log book for all devices and every action of taken during AMC need to be logged.
- 5. Snapshot Documentation of Network statusalong with configuration of devices, at the time of commencement and at the end of the Service period will need to be prepared and submitted to network committee.
- 6. In case of failure of devices/components under AMC the onsite engineer will initiate the service call log process with OEM on behalf of Institute. Complete process of fault rectification will be handled by the firm.
- 7. This support and maintenance will include (but not limited to), at no additional cost and for the entire duration of the AMC, the following:
 - a. Ensuring proper operation and maintenance of all the devices and their software components 24x7 during AMC.
 - b. Renewal and update of Software, Firmware and subscribed Service Licenses of the devices and services.
 - c. Configuration of the devices as necessary or requested by IIIT-A.
 - d. Fine Tuning of configuration to provide optimum utilization of network devices.
 - e. Scheduled service of the listed devices and replacement of the devices as necessary or upon failure.
 - f. Regular updates to the devices (firmware and functionality providing software).
- 8. Agency has to submit a copy of Cisco SMARTnet contract notification and welcome kit after renewal of the technical services support of devices under AMC from Cisco. The agency also needs to notify network committee about service support period (last date) from Cisco for the devices under AMC.
- 9. The firm will provide complete documentation of the steps taken to reconfigure setup or modify any of the listed devices.
- 10. The firm will ensure that the necessary spares are available either at IIIT-A campus or delivered within 48 hours of a device failure or issue being reported.
- 11. The firm will ensure that the security and integrity of the IIIT-A network is not compromised in anyway and unauthorized access is not provided to any individual/agency.
- 12. The firm will ensure that only those persons authorized by the network committee have access to the listed devices in as far as viewing their operation and /or making configuration changes.
- 13. The Service Engineer deployed by the firm shall not tamper with any other installation of the Institute.
- 14. The firm shall take all precautionary measures for the safety of the workers during performance of their duties at site and in case of any untoward incident; Institute shall not be liable to pay any compensation to any workmen and/or employee of the firm.
- 15. The firm shall use only genuine spares, wherever applicable.

- 16. The devices shall be handed over in perfect working condition after the expiry of the contract, by the agency.
- 17. The AMC will be valid for one year from the date of the award, following which the contract may be renewed after satisfactory performance report from the site incharge/competent authority.
- 18. Payment will be made in three parts.50% an advance after signing agreement & providing PBG of the same value in the form of TDR/FDR and intimation of contract renewal confirmation from the OEM.25% after successful completion of AMC for the period of six month and rest 25% after successful completion of AMC and satisfactory report & recommendations of Networking Committee of IIIT Allahabad.
- 19. **Stocking of Spares:** Spare parts stocking station and ensured prompt availability of the spares. The supplier/vender awarded the AMC is required to maintain sufficient spares stock at site during the AMC period to ensure the up term commitments.
- 20. The quoting firm must have at least five CCIE and CCNA certified engineers employed by them (with proof of the same).
- 21. The quoting firm must have documentary evidence towards maintenance of similar infrastructure at other sites.

In case any of the above conditions are violated, a suitable penalty clause will come into effect.

The penalty may be imposed as below:

- i) For points 1, 2, 3, 4 and 5: in the event of violation of these conditions, the contract awarded may be cancelled along with recovery of any monies already paid to the vendor by the institute.
- ii) For points 6,7,8,10,11 the penalty will be assessed according to the following rule:

After a problem is reported, if not rectified

- a) INR 5000/- per day after 48 hours that the problem goes unrectified for the first 7 days.
- b) INR 75000/- per week after the first 9 days of the problem being reported- that the problem goes un-rectified.
- c) Termination of the contract and recovery of the monies already paid to the vendor by the institute.
- d) In exceptional cases, the Institute reserves the right to raise/lower the penalties.

General Terms and Conditions:

- 1. Rate should be quoted F.O.R. destination at IIIT-A, Deoghat, Jhalwa, Allahabad.
- 2. The tender is to be submitted in two part viz "Technical Bid" and "Commercial Bid" in two separate sealed envelopes separately. The commercial bid will be opened only after acceptance of "Technical Bid".
- 3. Based on the evaluation of the technical bid submitted by the tenderer, the committee would shortlist the tender. The short listed tenderers may be asked to make a presentation after opening of the technical bid before the committee if, required.
- 4. **Authorization:** The tenderer should be an authorized dealer/reseller of the Equipment /Original Equipment Manufacturer (OEM) and a certificate to this effect should be enclosed with the technical bid.
- 5. Annual Turnover of the firm should be 1 crore or above for the last three years separately.
- 6. Certificates/documents showing the satisfactory performance AMC of the orders, along with tender documents list of Clients with value of AMC may also be submitted.
- 7. In case of acceptance of the bid, the successful bidder must enter into a contract agreement on Non-Judicial Stamp Paper valuing Rs.100/- within fifteen days from the issue of the Detailed Award Letter.
- 8. <u>Security Deposit</u>: The Person/Firm whose tender be accepted deduction of 5% of the total amount will be made against security deposit during AMC period after adjusting the EMD amount already submitted alongwith the tender or Bank Guarantee to the value of the same amount be submitted with confirmation of the same from Nationalized Bank.
- 9. Trade/Sales tax/VAT/ Service Tax or any other tax or other charges on the material, which has not been mentioned while quoting their rates shall not be paid by the Institute under any circumstances. The firm has to bear all taxes.
- 10. Upon verification/evaluation/assessment, if in case any information furnished by the Bidder is found to be false/incorrect, their bid shall be summarily rejected and no correspondence on the same shall be entertained. It is the responsibility of bidder to verify the authenticity of any third party document being submitted as part of the eligibility requirements. EMD will be forfeited if any forged or false document is submitted.
