12. The defect liability period will be 12 month from the date of completion. 5.0% of the total value of the tender will be deduct from the agency bill and same will be released after completion of defect liability period.
13. The mentioned quantity is approx quantity; it may decrease/increase by upto 10%. The payment will be made as per actual measurement/supply, as certified by E I/C.
