Indian Institute of Information Technology- Allahabad invites open offer of interest for "Empanelment of Vendors for the Supply of Books" on prescribed format from reputed vendors/distributors/library suppliers in India, to Library, IIIT-Allahabad.

This empanelment will be valid initially for 1 year which may be extended to further one year on satisfactory completion of first year (from 1st April, 2017 to 31st March, 2018 & 31st March, 2019).

Interested vendors/distributors/library suppliers may submit the applications along with one copy each of the requisite documents to "Deputy Registrar (S&P), Indian Institute of Information Technology Allahabad, Deoghat, Jhalwa, Allahabad $-211\,012$, U.P".

Last Date for Submission of Applications: 20th February, 2017 till 5.00 pm.

Registration Fee: Rs. 5,000/- (Non-refundable), shall only be paid by the empanelled vendors within 10 working days after intimation of their empanelment.

> Instructions for applicants:

- i. Interested vendors/distributors/library suppliers should submit application form in sealed envelopes super scribing "Application for Empanelment for the supply of Books to Library, IIIT Allahabad".
- ii. The application should be signed by an authorized signatory of the vendor(s) bearing his/her full name and status, clearly indicated below the signature along with the official seal of the firm.
- iii. Incomplete and conditional applications will not be considered.
- iv. At any given point of time, if any of the documents furnished by the vendors/suppliers is found to be false, it would be deemed to be a breach of terms of contract making the firm concerned liable for legal action besides termination of empanelment.
- v. Strict discipline is expected to be maintained with respect to application for empanelment. No canvassing or repeated communication should be made with the library. Failing to maintain this discipline, the applicants are liable to be black-listed by the institute.
- vi. The received application(s) after the due date and time will not be considered.
- vii. The short-listed vendor(s)/distributors(s)/library supplier(s) for empanelment are required to agree to supply as per the Institute's "Terms & Conditions for Supply of Books" as stipulated hereunder.

Empanelment of Vendors for Supply of Books to Library, IIIT-Allahabad

- > The empanelment will be governed by the following 'Terms and Conditions"
- 1. General:
- a) The Director, IIIT-Allahabad reserves the right to approve or reject any or all the vendors. His decision will be final in all cases in respect of acceptance/rejection/ arbitration.
- b) IIIT-Allahabad reserves the right to add any additional vendor to the approved list of vendors or to place the purchase order to any of the vendors.
- 2. Purchase Orders:
- a) Supply of books has to be made strictly against and as per the purchase orders.
- b) Sending the acknowledgement of the receipt of purchase order, which is taken as acceptance of the purchase order, is mandatory, preferably by email.
- c) Any clarification/query regarding the purchase order should be sought from the Library within two (02) days of receipt of the order.
- 3. Supply:
- a) The supply should be free of freight charges.
- b) Consignee and Mode of Dispatch: The books should be sent to LIBRARY, INDIAN INSTITUTE OF INFORMATION TECHNOLOGY ALLAHABAD, ALLAHABAD 211 012, by Speed Post/Parcel/Registered Parcel/Courier/Person. The charges will be borne by the supplier. Books sent via V.P.P. will not be accepted.
- c) Every supply should be accompanied by a delivery challan, clearly bearing the details of the items and titles in supply, their quantity and price.
- 4. Timeframe for supply, and cancellations:
- a) Four (04) weeks (maximum) for Indian titles
- b) Eight (08) weeks (maximum) for Foreign titles
- c) After the expiry of timeframe, the purchase order automatically stands cancelled.
- d) Separate permission for supply of the cancelled titles should be sought from the Library through email.
- e) The decision of accepting supply of cancelled titles is at the sole discretion of the Institute.
- 5. Edition specifications:
- a) Latest editions of books must be supplied, unless mentioned otherwise.
- b) Paperback editions of books should be supplied, unless specified otherwise (having e-supplements).
- c) Indian editions of books should be supplied, unless mentioned otherwise.
- 6. Invoicing procedure:
- a) Pre-receipted invoice(s)/bill(s) are to be submitted in duplicate (2 copies).
- b) A revenue stamp should be affixed on the original bill and should be signed by authorized signatory.
- c) Invoice should be raised in favour of Faculty In-Charge (Library), Indian Institute of Information Technology Allahabad, Deoghat, Jhalwa, Allahabad 2111012, UP.
- d) One invoice should be raised against one purchase order (P.O.) only. Titles from different P.O.s should not be combined and supplied under one invoice.
- 7. Undertaking: Every invoice should certify the following.
- a) The prices charged in this invoice are the actual, current publisher's prices as billed to us; and are true and correct.
- b) The prices charged are as per the publisher's invoice (publishers/importers/distributors) and latest catalogue.
- c) The latest editions have been supplied, and they are not remaindered titles.
- d) The books supplied against this order have been checked against defects in collation, binding, and condition of accompanying material viz., CDs/DVDs etc., and for other physical conditions. If any defects are detected later, the defective books will be replaced without any payment by the institute. The vendor will be liable to arrange for supply of replaced books at the destination of supply.

8. Mandatory enclosures with invoice:

a) A copy of publisher's invoice as a price proof.

b) A currency conversion proof (Bank rate (RBI) as prevalent on date of billing).

c) Every price proof and currency conversion proof should contain seal and authorized signature of the vendor.

9. Discount: The following discount pattern should be followed:

S.N.	Description	% of discount
1	All books (except Handbooks, Dictionaries and Encyclopedias etc.)	20%
2	Handbooks, Dictionaries and Encyclopedias etc.	30%

If the book(s) is/are available with online vendor(s) rather than its own publisher/importer/distributor, supply must be done by the impaneled vendors making procurement through online vendor(s). This may be done only after due approval. Governing terms and conditions in this regard are as follows-

- a) Discount rates sought as above would not be applied on such procurement. Actual amount (mentioned in bill/invoice of online vendor) would be paid / reimbursed by the institute.
- b) Additional 10% of actual bill/invoice would be paid by the institute as handling charges.
- c) In such cases, supplier is required to produce supporting documents of 3-4 online vendors. Only lowest price would be considered.

In case of government publications on which supplier(s) is/are getting NO discount, actual amount of bill/invoice + 10% handling charges would be paid by the institute. To take advantage of this, supplier is required to produce supporting documents.

10. Conversion Rates:

a) The prices in the invoice should be indicated in original currencies.

b) Reserve Bank of India's (RBI) Currency conversion rates as applicable on the date of the purchase order should only be followed, and should also be clearly indicated on the invoice.

11. Return of Bad Books:

If a supplied book does not confirm to specifications or if the book is not in good condition, the Supplier will be asked to take back the book at his own expense and replace it within one month; otherwise the order will be cancelled. The Library will not be responsible for such books if not taken back and replaced within the said period.

12. Termination of empanelment:

A vendor's empanelment may be terminated/dropped/black-listed from the panel of suppliers at the occurrence of any of the following event:

- a) If the vendor fails to deliver even, at least 70% of the supply (in terms of number of titles) during the year.
- b) In case of breach of any terms of agreement, or unsatisfactory/inefficient working on the part of the vendor.
- c) If at any time it is found that the information provided by the vendor in any form about publications, services and related matters are incorrect and result in losses in any form to the Institute.

In such case(s), the institute will be at liberty to terminate the empanelment without giving any prior notice to the vendor/supplier, and the Institute reserves the right to claim the amount of loss occurred to the Institute, from the available invoices submitted by that vendor / supplier.

- 13. The Institute reserves the right to change or modify or amend or substitute any clause in the terms and conditions that are listed above if required, at any time.
- 14. All disputes and differences arising out or concerning the work shall be subject to the sole arbitration of Director, IIIT-Allahabad or his nominee. The decision of the arbitration shall be final & binding on both the parties. The empanelment will be interpreted under Indian Laws and disputes adjustable within the jurisdiction of court of law of IIIT-Allahabad.
