- 2. The scrap materials shall be picked from the following location/area:-

- 3. Quotations are to be submitted in sealed covers and should be submitted within the last date and time specified in the tender document.
- 4. The quoted price, item-wise, shall be submitted in the Price Format at Annexure-C, forming part of the Tender Inquiry. Prices are to be quoted for both the items.
- 5. The tender shall be open for acceptance for a period of ninety (90) days from the date of opening the bids.
- 6. The tender shall be written legibly and free from erasing and over-writing. Corrections, if any should be duly countersigned by the authorized signatory. Rates should be written both in words and in figures. In case of difference in the rates indicated in figures and words, the rates indicated in words would be treated valid.
