Terms and Conditions

- 1. The company shall be responsible for providing the Group Personal Accidental Death Insurance coverage to the employees of the Institute, as per the provisions stated in the enquiry document.
- 2. The tenderer should sign & stamped the tender form at each page at the end in token of the acceptance of all the terms and conditions of the tender and agreement.
- 3. The company should be registered with the Income tax Department and in support shall endorse PAN Card and income tax clearance from the Income Tax Department with the tender.
- 4. Successful tenderers will have to execute an agreement in the prescribed form and deposit security amounting to 10% of the total value of contract for the due performance of the contract. The security money will be returned after two months from the date of completion of the agreed contract. No interest will be paid by the department on such security amount. The expenses of completion and stamping the agreement shall be paid by the agency and the department shall be furnished free of charge with one executed stamped counterpart of agreement.
