Terms & Conditions:

- (i) **Supplier capability:** The bidder should have Technical expertise in implementing RAM in a HPC cluster, which includes installation configuration, maintenance and customization as per requirement at the destination.
(ii) The bidder must have supplied, installed, and integrated at least 5 similar systems in the last 3 years across India, preferably in IIT's/NIT's/Edu & R&D Labs/other CSIR Labs. Please provide a list of your installations and satisfactory/installation report.
- (i) The server and all its components should be verified and recommended by the motherboard (Supermicro) manufacturer by means of compatibility list. No else will be accepted.
(ii) The part number/model numbers of the memory should be provided.
- Installation, Warranty and Training:**
(i) The bidder is responsible for the final delivery of the said RAM, which is at the Indian Institute of Information Technology-Allahabad.
(ii) The vendor shall install and configure all required hardware and relevant softwares, including but not limited to racking and stacking, cluster networking, configuring all nodes, installation of open source compilers and applications, configuration of

environment variables and license utility configuration, as demanded during RAM installation *at the final destination*.

(iii) The vendor to ensure that the hardware and software components are compatible with each other, and provide necessary cables/wires and any other accessories necessary for connecting the supplied components. Bidder must install the complete system interconnecting all the components above.

(iv) **Please provide costing additional 4th & 5th year warranty (Optional)**

5. Preference may be given to the vendors who have supplied these types of servers.
6. Quoted rate should be valid at least for 60 days.
