**Terms and Conditions:**

1. F.O.R. destination at Indian Institute of Information Technology, Allahabad
2. Preference will be given to Govt. approved contractors registered in appropriate class.
3. Quoted rate should be valid at least for 45 days from the opening date.
4. **Turnover of the firm should be 10 lakh annually for the last two years.**
5. The mention quantity is approx quantity; it may decrease/increase upto 20%.
6. **The quality and specification be adhered to strictly. If not found according to specification, supply will not be accepted. The item which is not included in BOQ, the same will be carried out according to DSR-2014 as per site requirement to the complete work.**
7. Bidder must sign in each and every page of the enclosed tender documents.
8. **Tenderer should have furnish copies of supply orders during last three years:**
  - Similar order** (Civil work/similar work) of value not less than 80% of tendered value of the items.
  - Or
  - Two similar orders** (Civil work/similar work) of value not less than 60% of tendered value of the items.
  - Or
  - Three similar orders** (Civil work/ similar work) of value of not less than 40% of tendered value of the items.
9. Enquiry/tender must be quoted in prescribe format on the company/firm letter head.
10. Security Deposit: L1 bidder will have to submit Bank Guarantee/FDR of 10% of total contract value from Nationalized Bank against performance guarantee which will be released after defect liability period 1 year. EMD may be adjusted against security deposit if desired or returned at the time of receipt of 10% BG.
11. The contractor shall stock 10% of executed quantity of asbestos sheet in IIIT-A and fix them within 7 days where ever fixing is required & comply with in defect liability period.
12. **The price quoted should be inclusive of all taxes.**
13. **Scope of work:**
  - (A) Supply and fixing of asbestos sheet to ensure the leakage from the same, thereafter the false ceiling will be fixed. After due certification from Engineer incharge/committee by CPC.**
  - (B) (i) The work of false ceiling associated with Asbestos sheet should be completed within 30 days after the clearance provided by the committee.**
    - (ii) The false ceiling work at other palaces should be completed within 45 days of issue of work order.**
14. Upon verification/evaluation/assessment, if in case any information furnished by the Bidder is found to be false/incorrect, their bid shall be summarily rejected and no correspondence on the same shall be entertained. It is the responsibility of bidder to verify the authenticity of any third party document being submitted as part of the eligibility requirements. EMD will be forfeited if any forged or false document is submitted.
15. Payment will be made within one month after completion of work and satisfactory report from engineer/indenter.

  21. **Defect Liability:** 12 months from date of completion of Job. If leakage is found after replacing the sheets without damaging other allied infrastructure. The contractor shall replace the sheets kept in stock within a week.
