1	Manufacturing supplying and fixing Avery Retro Reflective Signage boards made up of 3mm thick Air Composite panel (ACP) sheet, face to be fully covered with high intensity and encapsulated lens type heat activated retro reflective sgheeting conforming to type –III of ASTM-D4956-01 as approved by Engineer-in-charge, letters, borders etc. as per IRC:67-2001 in silver white pasted on sustrate by pressure conforming to class II of ASTM-D-4956-01 and fixing the same to the plate of structural frame work by means of suitable size of 3mm×600mm×900mm ACP Sheet riveted on stainless steel-304 grade of 25mm×25mm×1.25mm(average thick)frame section or round and outer 50mm OD circular pipe of an average thick 1.25mm to be fixed as boerder. The vertical arms will be made by Stainless 304 grade 80mm OD circular/ round pipe with a minimum thick 1.25mm up to a hight of 2440mm and base mounting arrangement should be a suitable size of SS along with a provision of 4 nos. anchor fasteners in each base for fixing the base on the ground. - 2. Preference will be given to the manufacturers /sole Distributers of authorized agency.
- 3. Minimum turnover of the firm should be Rs.5 lakh or more in last two financial year (2015-16 & 2016-2017).
- 4. Quoted rate should be valid at least for 60 days GST will be mentioned separately base allocated rates.
- 5. The mention quantity is approx quantity; it may decrease/increase up to 10%.
- 6. Enquiry/tender must be quoted in prescribed format on the letter head of the firm/vendor, otherwise quotation may be rejected.
- 7. Work should be completed within (05-06) weeks from the receipt of the Work/Purchase order. If, the work/supply delayed beyond the stipulated time of completion of work/supply penalty of 1% per week of total cost may be imposed at the discretion of competent authority. The penalty may be upto 10% of the total cost.
