1. F.O.R. destination at Indian Institute of Information Technology, Allahabad
2. Quoted rate should be valid at least for 60 days from the opening date.
3. Turnover of the firm should be **10 lakh for the last two year.**
4. The firm must have necessary ISI certificate in case of manufacturer and the valid dealership certificate in case of Authorized Dealer/Supplier of ISI fire extinguishers.
5. The firm must be at 5 years old in the same field of business.
6. The mention quantity is approx quantity; it may decrease/increase upto 10%.
7. Bidder must sign in each and every page of the enclosed tender documents.
8. The vendors are required to **furnish copies of minimum 02 work orders amounting to Rs.6 Lakh per annum or more last two year relating to supply of ISI fire extinguishers.**
9. Enquiry/tender must be quoted in prescribe format on the company/firm letter head.
10. It is most essential that it should be mentioned clearly that the price basis, payment terms, works schedule taxes and duties, validity, transportation charges.
11. The relative documentary proof in respect of above conditions/requirements should be enclosed with tender without which tender will be summarily rejected.
12. Trade/Sales tax/VAT or any other tax or other charges on the material, which has not been mentioned while quoting their rates shall not be paid by the Institute under any circumstances. The firm has to bear all taxes.
13. Upon verification/evaluation/assessment, if in case any information furnished by the Bidder is found to be false/incorrect, their bid shall be summarily rejected and no correspondence on the same shall be entertained. It is the responsibility of bidder to verify the authenticity of any third party document being submitted as part of the eligibility requirements. **EMD will be forfeited if any forged or false document is submitted.**
14. Payment will be made within fifteen days after completion of work and satisfactory report from engineer/indenter.

18. The lowest rate will not be the basis of claim to get the order.
19. Work should be completed within 6-7 weeks from the receipt of the purchase order. If the work delayed beyond the stipulated time of completion of supply, penalty of 1% per weeks and maximum upto 10% of the total cost may be imposed at the discretion of competent authority.
20. Conditional tenders will not be considered in any case. They will be summarily rejected.
21. All disputes are subject to jurisdiction of Courts at Allahabad.
