Institute intends to Purchase of Medicine for IIIT-Allahabad for which quotations are invited as per details attached **Annexure-I.**

You are requested to submit the quotation by courier/speed post with complete details of specifications, terms & conditions warranty/guarantee etc. upto 20/03/2018. Quotations duly sealed may be dropped in the tender box placed in the office of the Faculty In Charge Purchase, IIIT-Allahabad. Basic rate, taxes and freight charges etc. must be quoted separately. Quotation should be addressed to Faculty In Charge Purchase, IIIT-Allahabad, Deoghat Jhalwa, Allahabad-211015. Kindly mention enquiry reference number, subject, due date contact address etc on envelops. Incomplete quotation will not be accepted.

Terms and Conditions

- 1. **Eligibility Criteria:** The tenderer must possess minimum eligibility criteria mentioned as under to participate in the tender:
 - a) Should possess minimum 01 year experience in the relevant field.
 - b) Should have minimum turnover of Rs.6 Lakhs per annum for the last two years separately.
 - c) All the Authorized distributor/stockiest/company should quote their rates of Ethical Brands of medicines only. Generic brand will not be accepted at any cost.
 - d) Bidder/Tenderer should give the certificate on his letter head that only Ethical Brand Medicines have been quoted/supplied. Without this certificate quotation will not be accepted.
 - e) Should be submitted attested photo copies of the drug licence.



- f) Copy of registration certificate under shop and Commercial Establishment Act of Central/State Government.
- 2. Quoted rate should be valid at least for 60 days.
- 3. The expiry period of medicines should be more than one year from the date of supply order.
- 4. The tenderer may please note that the tender once submitted will not be altered in any case and should not have any scope of ambiguity, cutting or over-writing. In case of over writing/cutting, if any, it must be authenticated with the signatures of the tenderer.
- 5. Enquiry/tender must be quoted in prescribe format (As attached Annexure-III) on the company/firm letter head.
- 6. Quality & Medicine if not, found according to our specification/make as above and standards supply will not be accepted. If it is found that items are fake or of substandard quality and not conforming to the required specifications, the firm will have to replace the fake/ sub-standard items with genuine ones immediately but they will also be liable to be blacklisted.
- 7. Rate quoted by the firm should not be higher than the MRP/ prevailing market rate.
- 8. The right to accept or reject any tender/ quotation, partially or wholly, including lowest quotation without assigning any reason whatsoever thereof or incurring any liability thereby is reserved with the Director, IIIT, Allahabad. The Director, also reserves the right to split the tender and place the orders for supply of item(s), mentioned in the enquiry letter on one or more tenderer. The decision of the Director, with regard to enforcement of these terms and conditions herein contained, as a result of breach of these conditions by successful Tenderer/s, shall be final and the Director, shall not be liable for any damage/liability put forth by the Tenderers at any stage of the transaction arising out of the enforcement of any or all herein contained terms and conditions.
- 9. In case the firm fails to complete the job within maximum specified period, Institute reserves the right to get the job done by any other firm and the difference of cost if any, will be recovered from the defaulting firm.
- 10. The EMD shall be returned to the bidder (s) whose offer is not accepted by the Institute within 15 days after finalisation and award of the contract without any interest. Unsuccessful bidders may collect the EMD (within next 10 days after finalization & award of the contract) from Purchase Section, IIIT-A between 3PM to 5PM on any working day after providing a copy of any Photo Identity Card. After these 10 days EMD will be sent by registered post to the postal address provided by the firm/bidder at point no.11. Representative may also collect the EMD on behalf of the bidder, after providing an authorization letter from the bidder along with a copy of his photo identity card. If the return of EMD is delayed for any reason, no interest/penalty shall be payable to the bidder.

Upon verification/evaluation/assessment, if any information furnished by the tenderer is found false/incorrect, their bid shall be summarily rejected and no correspondence on the same shall be entertained. It is the responsibility of tenderer to verify the authenticity of any third party document being submitted as part of the eligibility requirements. EMD will be forfeited if any forged or false document is submitted.
- 15. Payment will be made within fifteen days after delivery & inspection of medicine.

- 20. The lowest rate will not be the basis of claim to get the order.
- 21. Supply within 3 weeks from the receipt of the Purchase order. If the supply delayed beyond the stipulated time of completion of supply, penalty of 1% per weeks and maximum upto 10% of the total cost may be imposed at the discretion of competent authority.
- 22. Conditional tenders will not be considered in any case and will be summarily rejected.
- 23. All disputes are subject to jurisdiction of Courts at Allahabad.
