- 2. **Bid:** The tenders are to be submitted in two part viz. "**Technical Bid" and "Commercial Bid"** in two separate sealed envelopes separately. The commercial bid will be opened only after acceptance of "Technically Bid".
- 3. Detailed specifications, catalogue/literature of all the items quoted should be supplied with the technical bid.
- 4. **Warranty:** Warranty will start from the date of successful installation report at IIIT-A. Warranty start and end date should be clearly mentioned in the bill duly signed & stamped and warranty card (as applicable) also.
- 5. **SECURITY DEPOSIT:** L1 bidder will have to submit Bank Guarantee/FDR of 10% of total contract value from Nationalized Bank against performance bank guarantee. Above amount shall be taken as a security deposit valid beyond 2 months of warranty period. EMD will be released after receiving of Bank Guarantee/Demand Draft.
- 6. **Delivery Schedule:** The supply and Installation period shall commence from the date of issue of confirm purchase order and completion period may be strictly 6-7 weeks.
- 7. **Payment:** Payment will be made within 15 days after acceptance of delivery of material, Installation and satisfactory report.
